Sub : Revision of charges for occupation of Officer's Rest House over N. Rly.

The rates of officer rest house in Northern Railway were last revised vide this office letter of even no. dt. 01.12.2004. Due to escalation of prices and revision of pay commission, it has been decided to revise the existing rates as under. The rates are applicable over Northern Railway.
