UP-DATED CONSTITUTION OF NORTHERN RAILWAY SPORTS ASSOCIATION

The General Manager has sanctioned the formation of a Sports Association on the Northern Railway and has approved the Constitution as appended below:-

CONSTITUTION

1-Name:

The Association shall be called the Northern Railway Sports Association with its Headquarters at Delhi.

2-Object:

The Object of the Association shall be:

To Organise, develop and promote Sports and Organise, authorise and control all Tournaments and Exhibition Games on the Northern Railway.

3-Composition of the Association:

The General Manager shall be the Patron on the Association. The Addl. General Manager (AGM) shall be the Vice-Patron of the Association.

The affairs of the Association shall be controlled by a General Committee which will consist of the following:

OFFICE BEARERS:

- i) President
- ii) Vice-President
- iii) Hony. General Secretary
- iv) Hony. Joint Secretary.
- v) Hony. Secretary-I
- vi) Hony. Secretary-II
- vii) Hony. Secretary-III
- viii) Hony. Treasurer
- ix) ~~Asstt.~~ ^{Sr.} Sports Officer
- x) Asstt. Secretary

President, Hony. General Secretary and Hony. Joint Secretary heretofore, be nominated by the Patron viz. the General Manager, whereas the Hony. Secretaries and Treasurers shall be nominated by the President.

Divl. Railway Manager (DRM) Delhi shall be Ex-Officio Vice-President of the Association.

MEMBERS:

- a) Three Members nominated by the Headquarters Committee Staff Benefit Fund.
- b) Two Members from each of the Eight Divisions and nominated by the Divisional Sports Officer.

CONTD-

c) Two Members each from Workshop, Headquarters and R.P.F. Divisions are nominated by Chief Mechanical Engineer, Chief Personnel Officer, and Chief Security Officer/Commissioner respectively. The three Divisions will be comprised as under:-

WORKSHOP DIVISION:

The C & W Loco workshop at Alambagh and Charbagh Lucknow including Kalka, JUDW and Amritsar Workshops.

HEADQUARTERS DIVISION:

Headquarters Office, District Controller of Stores, Shakurbasti, Signal Workshop Ghaziabad, Track Depot Ghaziabad, Rajpura Workshops, Bridge Workshop, Jalandhar Cantt., T.A., Jalandhar, Stores Depot and Power House.

R.P.F. DIVISION:

R.P.F. Training Centre at Lucknow, RPF personnels posted in all the Divisions of Northern Railway, RPF Personnels of Northern Railway posted in RCF Kaputhala and DCW Patiala.

NOTE:

For purpose of Sports, the staff of different Branches will form a part of the Division in Territorial Unit of which they are employed.

WORKING COMMITTEE:

The day-to-day business of the Association shall be controlled by a Working Committee consisting of the following:-

Two Members of General Committee to be elected by the Committee at its Annual General Meeting.

5-BYE-LAWS:

The General Committee shall frame Bye-Laws for the conduct of business of the Association.
