NOTIFICATION

Applications are invited from eligible Male Candidates for recruitment to fill up (05) Five posts in PB-1 Grade Rs. 5200-20200+G.P. 1800 (NPS) erstwhile Group 'D' through the process of Open Advt. against Sports Quota on Ambala Division for the year 2014-15 on the prescribed application form as given. Candidates who possess the requisite standard in the discipline of the under noted sports events are only eligible to apply. Application duly completed in all respect should be **Addressed to Divisional Personnel Officer and sent to the office of Divisional Railway Manager, Northern Railway, Ambala Cantt (Haryana) through ordinary Dak or may be dropped in Box provided in Sports Cell, DRM Office, Ambala Cantt latest by 31-07-2014 during 10-00 Hrs to 18-00 Hrs on working days.** Applications received after the closing date i.e. last date 31-07-2014 will not be accepted and it will be treated as receipt late than the last date of receipt of application. It should specifically be mentioned through Red Ink on the envelope of application in BOLD LETTERS (Application for Recruitment through the process of Open Advertisement against Sports Quota on Ambala Division for the year 2014-15). Applicants must have to fulfill the following eligibility conditions.

ELIGIBILITY CONDITIONS:

1. **Essential**
 - (A) Represented the country in Commonwealth Championships (Junior/Senior Category).

OR
 - (B) Represented the country in Asian Championship/Asia Cup (Junior/Senior Category).

OR
 - (C) Represented the country in South Asian Federation (SAF) Games (Senior Category).

OR
 - (E) At least 3rd position in Federation Cup Championships (Senior Category).

OR
 - (F) Represented a State of equivalent unit except in Marathon and Cross Country in Senior/ Youth/Junior National Championships.

OR
 - (G) At least 3rd position in Senior State Championship for all units and Districts of the state.

2. As per instructions contained in Railway Board letter No. 2011-E/Spors/4(1)/1/Policy/ Clarification dated 11-01-2012, the sports persons having the sports norms/qualification for Higher Grade Pay and applied against the vacancy for the lower Grade Pay can be considered for Recruitment against Sports Quota through the process of Open Advertisement quota.

3. **In team sports, only sports persons who have actually played the sport in the field, shall only be eligible. Therefore, a sports person who represents as member of a team in any recognized sports event/championship but has actually not played in the field shall not be considered for recruitment against sports quota. Candidate must have to submit a certificate of competent authority of that sports event/championship for actual participation in the field of play. Application without this certificate is liable to be rejected. The candidate who have not actually played in the field in sports event /championship will not be considered for recruitment.**

4. Detail of Posts to be filled through the process of Open Advertisement Quota is as

(Only current Annual All India Ranking shall be considered for these purpose. Ranking in Mixed-Doubles shall not be considered.)

3. Athletics (Male) 01 (One) 1000 Metres (Ten Thousand Metres)

5. **Educational Qualification:** 10th from Recognised School (Board) Institution.

6. **Age Limit:** 18 to 25 years as on 01-07-2014. Candidates should not below 18 years and should not above 25 years as on 01-07-2014. No relaxation in lower or upper age limit is permissible in the recruitment.

7. **Period of Sports Achievements/Certificates to be considered:** For Recruitment against sports quota, recognised sports achievements should be in the current and/or immediate previous two financial years in the case of Open Advertisements Quota and Sports person should be active player. Certificates prior 01-04-2012 will not be considered.

8. **Examination Fees:** For General & OBC Candidates Rs. 40/- (Forty Only) by Indian Postal Order (IPO) in favour of Sr. DFM, N.Rly., Ambala payable at Ambala. For SC/ST Candidates Rs. 10/- (Ten Only) by IPO (Indian Postal Order) in favour of Sr. DFM, N.Rly., Ambala payable at Ambala.

Examination fees is not refundable under any circumstances including time barred/ rejected applications. IPO obtained earlier than than the date of issue and later than closing date of the Employment Notice will not be accepted. In complete & applications received after 30-07-14 will not be considered.

9. **Selection:** (1) Eligible candidates will only be called for Trial and interview and will be informed through Regd. Postal Letter. (2) Railway Administration reserve the right to cancel the selection in the exceptional circumstances and or in the event of any change in the recruitment policy. (3) Only the candidates who possess the prescribed qualification may apply otherwise the application will be rejected. (4) Without requisite documents, in sport of eligibility conditions, application will be rejected. (5) Application of candidates signed in Block letters in application form will be rejected. (6) One spare self signed passport size photograph and photocopies of all certificates duly attested by a Gazetted Officer may be attached with application Form. (7) Candidates are also advised to bring their original documents & certificates at the time of Trial & Interview. (8) Attach two self addressed registered envelopes. (9) This office will not be responsible for any postal delay or wrong deliveries, candidates sending their applications by post are advised to post their applications sufficiently in advance, so that it reached in this office during working hours up to 18-00 Hrs. on or before the closing date. (10) Issue of certificates for participation and medal winning performances on letter head are liable to be rejected and will not be considered for recruitment purpose. (11) Any dispute shall be subject to jurisdiction of CAT/ Chandigarh. (12) Selection shall be through the process of Trials and Viva-Voce (Interview). Candidates who found fit in Trial will only be called for interview and selection shall purely be based on overall merit. Selected candidates can be appointed in one of the category in various categories at any station in Ambala Division of Northern Railway and candidate must have to pass the prescribed medical examination.
